

First Discussion Held of Possible City Management

The first meeting between Lenexa city governing officials and the membership of LHS was Thursday, January 27. Forty people attended. Those from the City were Council members Mike Boehm, Diane Linver, John Ramsey, Jane Klein, and Mayor Joan Bowman. All are also LHS members.

This meeting was to determine whether or not the majority of LHS members favor city management of the Barn.

LHS President Mary Kay Smith, LB Museum Director Peggy Stanton, and Mayor Joan Bowman composed a panel leading the discussion. Mayor Bowman started out by saying that she had been advised by City Staff that while the City doesn't necessarily want to manage LBM, there may be some positives for the City to operate the museum complex. She also said it was her understanding that LHS' ability to raise funds and provide volunteers at the Barn had decreased.

Mayor Bowman assured the members that she is interested in keeping the relationship between the City and LHS as good as it has been in the past. She stated that the entire membership needs to participate in this part of the planning for the museum's future. If LHS prefers other options to City management, they need to be clearly defined and an outline of procedure needs to be made.

The evening's discussion touched on many subjects, such as whom should own the collection, benefits for Barn employees if they were City employees, how other museums are doing which are operated by government as opposed to non-profit groups, and what plans does the City have to increase the transient guest tax, from which funding for LBM comes now.

Peggy stated an intention to talk to a respected and experienced authority, Dan Holt, of the Eisenhower Museum in Abilene, on the subject of government vs. non-profit museum operation. In the meantime, she presented some information that she had researched. Some of the benefits of LHS retaining management are:

- Many museum grants are not available to government entities
- A non-profit group is better protected by the law in the event of a lawsuit
- Sometimes governments are less accepting of Museum Standards and Practices if they don't see the value in them

Some of the benefits of City management are:

- LHS funds could be used to improve the collection and related programming for the public

- Probably, more staff could be hired. LBM is understaffed and pay levels don't meet those of the Museum Field.

- LHS could devote more time and energy to other aspects of historical preservation, research, etc.

Peggy suggested that a new museum board be established, comprised of LHS members and City Staff. It would ensure accountability to LHS and the City. It was agreed that that was a good idea, and should be done, if City management occurs.

All those present understood that no definitive answers would come from this meeting. However, it was agreed that a task force to research and discuss the situation be formed. The task force would consist of several members of City Staff and LHS. (A task force has since been formed. See page 2 for related information.)

Nancey Makes Good Cookies!

Nancey Spaith made such good macaroon cookies for the January membership meeting that many people asked her for the recipe. Here it is.

Nancey Spaith's Grandmother's Holiday Macaroons

2 eggs
3/4 cup sugar
1/3 cup flour
1/4 teaspoon baking powder
1/8 teaspoon salt
1 tablespoon melted butter, cooled
1 teaspoon vanilla
2 2/3 cups coconut

Beat eggs until foamy. Slowly add sugar and beat until thickened, about 5 minutes. Fold in flour, baking powder and salt. Then fold in butter, vanilla, and coconut. Drop from teaspoon or melonballer onto greased and floured cookie sheet (or use parchment paper on cookie sheet.) Bake at 325 degrees until cookies are brown around the edge, about 15 minutes. If you are using two racks in the oven, bake for 7 1/2 minutes, switch racks, and bake another 7 1/2 minutes. Makes 3 dozen. For a festive look, place a candied cherry in the center of each cookie before baking.

New Traveling Education Trunks Being Formed

I volunteer for the Legler Barn Museum. My background is education and I am currently developing the first of what is hoped to be several traveling education trunks. Our goal is to serve the community by creating a unique teaching tool for the use of educators in Lenexa and the surrounding area.

The trunks are designed to be a complete unit that is teacher-friendly, with a variety of activities that integrate history with reading, math, science and geography in a fun format. The curriculum is scripted so teachers can easily present their choice of sub-topics and select extended activities for more in-depth study of a topic. The trunk contains audio-visual materials such as photographs, maps, charts, videos, and music. Objects, artifacts, and reproductions, will be included to provide visual and tactile experiences for the students. We hope to have the first trunk completed by mid-summer so we can introduce the trunk to teachers as the school year begins.

The first trunk topic is The Santa Fe Trail and while we have been collecting materials, there are many opportunities for patrons of history to assist in this worthwhile endeavor. The following is a partial list of items we need to fill the trunk. Please keep in mind duplicates are welcome as replacements for lost or damaged objects. We also invite readers to make suggestions for appropriate objects for the period of 1820 to 1870. If you can

help by donating an object, or providing funds or services, please contact the museum.

- Trunk, storage container, large cooler or suitcase with wheels and handle
- Old genuine quill and ink well
- Wire-rim glasses
- Medicine bottles
- Wagon wheel spokes or hub (doesn't have to be a complete wheel)
- Tinware or graniteware items, chamber pot, water ladle, etc.
- Sewing kit items
- Old leather-bound ledgers and personal journals
- Small wooden keg (even better if it holds water)
- Wooden spigot
- Cobbler form and stand
- Kerosene lantern
- Hat pins
- Darning egg
- 4" to 6" thick, large foam scraps for packing
- Kansas City Centennial items
- Postcards of Santa Fe Trail sites, the older the better
- Books, video tapes, and music cassettes on the Santa Fe Trail

In addition to specific items, we need funds for laminating paper materials and small display cases for individual objects. We also need a volunteer to type from text, a person to do some calligraphy, and woodworker or craftsman that can do small assembly tasks. Thank you!

Board Action

At the February meeting, the following 2000 LHS goals were set:

- Develop programs to involve school-age children, thus interesting them and their parents in membership in LHS.
- Put the names and addresses of new members in the next newsletter.
- To publish a new booklet called "Historic Firsts of Johnson County."

- To continue to identify and mark historic places.

After discussion it was decided that the following committees would not be retained: Automation, Strategic Planning, and Long-term Fundraising.
